## Tennis Enthusiasts!



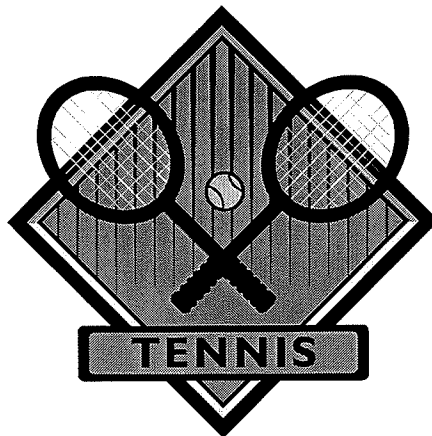
Based on a survey of River Place residents in 2002, there was a significant interest in having tennis courts available for residents and other people in the River Place area. In 2003, the River Place Municipal Utility District contracted to have two first class tennis courts built at Woodlands Park near Lake Austin.

The tennis courts have been a popular addition to the River Place Park System. River Place homeowners/residents (people who pay their water bill to the River Place MUD vs. the City of Austin) pay \$50 a year for a family membership. People who live outside of the River Place MUD pay \$200 a year for a family membership. There is an online reservation system and there has been little difficulty in obtaining court time.

In October each year, the locks on the tennis courts are changed. Entry to the courts is available to those who have paid the annual fee and completed the Application and Indemnification form for the upcoming fiscal year. The annual fee is used to defray expenses such as the online reservation system, court maintenance and administrative charges by Severn Trent Services.

Please complete the form on the back of this page and mail or bring the form and payment directly to Severn Trent Services, 14050 Summit Drive, Suite 113, Austin, TX 78728-7101 before October 1, 2008 in order to have a key that will work on that date. Your key will work until September 30 of the following year. If you wish to begin playing during the year, your key will be usable until September of the following year.

If you choose use the U.S. Postal Service, your key will be sent you by mail once the form and check are received. New players will receive a user name and password for the online scheduling program ([www.woodlandsparktennis.com](http://www.woodlandsparktennis.com)) via e-mail. We agree to indemnify and hold harmless the District, its officials, agents, independent contractors and representatives, whether paid or volunteer, from any and all claims by us or our guests which may arise out of use of the District's tennis courts. If this application is on behalf of any minor children, the application represents that the applicant is the legal guardian of said children and fully responsible for such children, and authorized to execute this application and release on their behalf. I understand that the children, if under ten (10) years of age, must be accompanied by a person fourteen (14) years of age or older when using the District's facilities. I further understand that I am responsible for any damage to District facilities caused by my family, my guests or myself. This membership may be renewed in accordance with District rules in which case all terms and conditions in the application will continue in effect.
