Once your application is processed, you will receive information for using the online reservation system via email.

I have made application for use of River Place Municipal Utility District's (the "District") tennis courts on behalf of myself and the listed members of my family. I understand that the District's tennis courts are for use of authorized persons only, and agree that all use by me, my family and our guests shall be in accordance with the District's Rules and Regulations. I agree that the District does not, by the providing of the tennis courts, assume any responsibility or liability to our guests or us. We assume all responsibility for, and waive any claim against the District, its officials, agents, independent contractors and representatives for accidental injury, property damage or death directly or indirectly arising out of the use of the tennis courts by any of our guests or us. We agree to indemnify and hold harmless the District, its officials, agents, independent contractors and representatives, whether paid or volunteer, from any and all claims by us or our guests which may arise out of use of the District's tennis courts. If this application is on behalf of any minor children, the application represents that the applicant is the legal guardian of said children and fully responsible for such children, and authorized to execute this application and release on their behalf. I understand that the children, if under ten (10) years of age, must be accompanied by a person fourteen (14) years of age or older when using the District's facilities. I further understand that I am responsible for any damage to District facilities caused by my family, my guests or myself. This membership may be renewed in accordance with District rules in which case all terms and conditions in the application will continue in effect.

WOODLANDS PARK TENNIS COURT RULES

1. Dangerous or offensive conduct or language is not allowed on courts.
2. Pets, bicycles, skateboards, roller blades, or motorized vehicles are not allowed inside the fenced court areas.
3. Court reservations have priority over drop-in usage.
4. Reservations are limited to 90 minutes
5. 15 minute "late arrival" applies before reservations are voided.
6. Members may have a maximum of two guests playing.
7. Maximum of four players on a court at any time except for drills.
8. Alcoholic beverages/glass containers are not allowed inside the fence court areas.
9. Black soled shoes are not allowed on the courts.
10. Court reservations are not to exceed four times during one week. Please provide the courtesy of canceling any reservation in a timely fashion to allow others to utilize the courts.

TENNIS COURT MEMBERSHIP & RESERVATIONS

There is a \$50 annual fee for residents who pay their utility bill to River Place MUD. The annual fee for out-of-District players is \$200. The fees are used to defray expenses such as the online reservation system, maintenance of the tennis facilities, and administrative costs.

After your application has been processed, you will receive a key for court access and a user name and password for the online reservation system.

RESERVING TENNIS COURTS ONLINE

Welcome and thank you for signing up for tennis at Woodlands Park.

The online scheduler for reserving court time is at <http://onlineschedulingsoftware.com/appointment/woodlands/> and the password to log into the reservation page is "**tennis**".

To access the reservations, your Username is the email address you supplied on your application for membership.

Your Personal Password is: (E-mail tennis@stes.com for your password)

To make a reservation:

- (1) Select the day you wish to play
- (2) Click "Click here" on Court 1, 2, 3 or 4 at your start time and follow the instructions

To cancel a reservation you have made:

- (1) Select the day you wish to cancel
- (2) Click on the blue "X" next to your name and follow instructions

Court reservations are not to exceed four times during one week. Each reservation can be 30 minutes to 90 minutes in length. Once you've scheduled your 4 reservations, you have to wait a week to schedule your next reservation. If you won't be able to play during a time that you had reserved, be sure to cancel your reservation in a timely fashion to allow others to utilize the courts.
